**SUPER RADIATOR COILS LIMITED PARTNERSHIP
SOFTWARE LICENSE AGREEMENT**

Super Radiator Coils Limited Partnership ("Super Radiator Coils") has developed certain computer programs and related materials (its "Computer Products") and is willing to make them available to the company or person who signs the Software License Agreement Acknowledgment (the "User") only upon the condition that the User agrees to abide by the terms of this License. Therefore, subject to the following terms and conditions, Super Radiator Coils grants to the User a personal, non-transferable and non-exclusive right to use its Computer Products only under the following terms:

Section 1: General Copying Restrictions. User may only make copies of the Computer products, except as this Agreement specifically permits, when authorized to do so in writing by Super Radiator Coils. Unauthorized copying of the Computer Products (including Computer Products that have been modified, merged or included with other software) and the acquiring and using of unauthorized copies of the Computer Products may be both criminal and civil offenses for which User may be liable for fines, damages and attorneys' fees. User agrees not to provide or otherwise make available any of the Computer Products, including but not limited to program listings, object code and source code, in any form, to any person other than User, User's authorized employees or Super Radiator Coil's employees for purposes specifically related to User's authorized use of the Computer Products without the prior written consent of Super Radiator Coils. Super Radiator Coils shall have the right to terminate this License and to take legal action if the terms of this License are violated by User.

Section 2: Archival Copies. User may make archival back-up copies of diskettes containing the Computer Products, but only if such copies are for the User's use as permitted by this License and further provided, however, that no more than five (5) copies of the Computer Products may be in existence under this License at anyone time. User agrees to maintain appropriate records of the number and location of all copies of the Computer Products. The original, and any copies, in whole or in part, of the Computer Products which are made by User shall be and remain the property of Super Radiator Coils, provided, however, that Super Radiator Coils will have no ownership interest in the media on which the Computer Product may be recorded. Upon discontinuance of this License, all Computer Products including those that have been modified, merged, or included with other software will be completely removed there from and returned to Super Radiator Coils. User shall not have the right to copy any Computer Products which are provided by Super Radiator Coils in printed form under this License.
